Accordingly Sealed tenders in duplicate, are invited from recognised & competent hospitals/nursing home and any other agencies in this regard for such health check up as per enclosed proforma only.

1. Nature of Work : Laboratory and diagnostic test.

3. Service to be provided in and around Kolkata, Howrah, Barackpore, Hooghly, Haldia, Kharagpur, Durgapur, Asansol, Malda and Siliguri directly or through tie up with any hospital/nursing home/ laboratory or pathological center.
