**ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY**

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the recommendation made by the Task Force Committee in its tenth meeting held on 13-09-2006 M/S. **A. K. CHATTERJEE & BORTHERS** located at 39L, Suren Sarkar Road, Kolkata – 700 010 is hereby directed by the Board not to operate their unit till further direction from the Board for the following reasons. It is also decided that the power supply of M/s. **A. K. CHATTERJEE & BORTHERS** will be disconnected forthwith.

- i. That, the unit is operating without obtaining requisite license from the Department of Forest, Government of West Bengal which is gross violation of the order of the Hon'ble High Court, Calcutta.

The General Manager-Operations(C&M), CESC Ltd. is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Phoolbagan Police Station under Kolkata. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Phoolbagan Police Station and the General Manager-Operations (C&M), CESC Ltd., in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Salt Lake Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
