ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the Inspection Report dated 21-06-2006 and in consideration of the recommendation made by the Task Force Committee in its tenth meeting held on 13-09-2006 M/S. **TUSHAR ENTERPRISE**, located at Vill.-Sahipur, P.O. – Fatepur, P.S. – Falta, Dist. – 24 Parganas (South) West Bengal is hereby directed by the Board not to operate their unit till further direction from the Board for the following reasons. It is also decided that the power supply of M/s. **TUSHAR ENTERPRISE** will be disconnected forthwith.

- i. That, the unit is operating without obtaining requisite license from the Department of Forest, Government of West Bengal which is gross violation of the order of the Hon'ble High Court, Calcutta.
- ii. That the unit is operating without installation of any pollution control system.
- iii. That, the unit is operating without obtaining "Consent to Operate" from the State Board since last one year.

The Secretary, WBSEB is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Falta Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Falta Police Station and the Secretary, WBSEB, in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Alipur Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
