ORDER FOR CLOSURE WITH DISCONNECTION WITH ELECTRICITY

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the recommendation made by the Task Force Committee in its tenth meeting held on 13-09-2006 **M/S. GHOSH SAW MILL, PROP.: SHRI NANDA DULAL GHOSH**, located at VILL., P.O. & P.S. – SALAR, Dist. – Murshidabad, West Bengal is hereby directed by the Board not to operate their unit till further direction from the Board for the following reason. It is also decided that the power supply of M/s. **M/S. GHOSH SAW MILL, PROP.: SHRI NANDA DULAL GHOSH** will be disconnected forthwith.

- i. That, the unit is operating without obtaining requisite license from the Department of Forest, Government of West Bengal which is gross violation of the order of the Hon'ble High Court, Calcutta.

The Secretary, WBSEB is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Salar Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report the State Board within seven day from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Salar Police Station and the Secretary, WBSEB, in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Barrackpore Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
