**ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY**

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the Inspection Report dated 08-09-2006 **M/S. SAW MILL RUN BY SHRI MONI MOHAN PAUL** located at Vill. & P.O. – Maniktala, P. S. – Ashokenagar, DIST. – 24 Parganas (North), West Bengal is hereby directed by the Board not to operate their unit till further direction from the Board for the following reasons. It is also decided that the power supply of M/s. **M/S. SAW MILL RUN BY SHRI MONI MOHAN PAUL** will be disconnected forthwith.

- i. That, the unit is operating without obtaining requisite license from the Department of Forest, Government of West Bengal which is gross violation of the order of the Hon'ble High Court, Calcutta.
- ii. That, the unit is operating without obtaining NOC/"Consent to Operate" from the State Board.

The Secretary, WBSEB is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Ashokenagar Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Ashokenagar Police Station and the Secretary, WBSEB, in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Barrackpore Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
