**ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY**

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 & Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the Hazardous Waste (Management & Handling) Rules, 2003 and its subsequent amendments and in consideration of the inspection report dated 22-06-2006 M/s. **SUPER CHEMICAL INDUSTRIES**, located at **Vill. – Enayet Nagar, P.O. – Chowk Enayet Nagar, P.S. – Bishnupur, Dist. – 24 Parganas (South) West Bengal** is hereby directed not to operate their unit till further direction from the Board for the following reasons.

- i. That, the unit is disposing its hazardous waste violating the Hazardous Waste (Management & Handling) Rules, 2003 and its subsequent amendments and thus attracting the order of the Hon'ble Supreme passed in W. P. (C) No.657 of 1995.
- ii. That, the unit was not operating the scrubber during its manufacturing operation for arresting acid fumes causing health hazard to the neighbouring people
- iii. **That the electricity connection of the said unit should be disconnected forthwith.**

The Secretary, WBSEB is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Bishnupur Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Bishnupur Police Station and the Secretary, WBSEB Ltd., in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Alipore Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
