ORDER FOR CLOSURE & DISCONNECTION OF ELECTRICITY

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder, in consideration of the Hazardous Waste (Management & Handling) Rules, 2003 and its subsequent Amendments and in consideration of the recommendation made by the Environmental Engineer – Howrah Regional Office in the Record of Proceedings dated 31-10-2006, **M/S. S.B,G.I. CENTRE** located at Balitkuri, Howrah – 711 104 is hereby directed by the Board not to operate their unit for the following reasons.

- i.. That, the unit is under “Special Red Category” of Industries and established violating the existing siting policy of the West Bengal Pollution Control Board

That, the unit is disposing its wastes which are hazardous in nature violating the Hazardous Waste (Management & Handling) Rules, 2003 and its subsequent Amendments thus attracting the provisions of the Hon’ble Supreme Court Order passed in W.P.(C) No.657 of 1995.

That, the unit is operating without installing any Air Pollution Control System.

The electricity connection of the said unit should be disconnected forthwith. The Secretary, WBSEB, is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Dasnagar Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Dasnagar Police Station and the Secretary, WBSEB, in conformity with the order of the Hon’ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Howrah Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
