### ORDER FOR CLOSURE AND DISCONNECTION OF ELECTRICITY

In exercise of the powers conferred under Section 33A (a) & (b) of the Water (Prevention & Control of Pollution) Act, 1974, Section 31A (a) & (b) of the Air (Prevention & Control of Pollution) Act, 1981, Environment (Protection) Act, 1986 and Rules made thereunder and in conformity with the orders of the Hon'ble High Court, Calcutta in Writ Petition No. 7255 (W) of 2000, and order of the Hon'ble Supreme Court of India in Civil Appeal No. 2735 of 2003 (arising out of S.L.P. (C) No. 4260 of 2002) the undermentioned Brick-fields **are hereby ordered to close their operation till 31<sup>st</sup> May 2007**, in compliance with the orders of the Hon'ble Courts as mentioned above for the following reasons :-

- I. That the following brick fields, during inspection on 10-05-2007, were found to be operating, which is clear violation the orders of the Hon'ble Courts passed in connection with the matters as mentioned above.
- II. That, the said brick fields are located with the vicinity of 1.6 Km. of Mango Orchards and are not permitted to operate from the period February to May, each year as per the orders of the Hon'ble Courts.

These are the following brick fields :-

- a) **M/s. Mandal Brick Field, Naskarpur, P.O. Bighati, P.S. Singur, Dist.- Hooghly, Pin- 712124, W.B.**
- b) **M/s. Balarampur Brick Field (BBF), Balarampur, P.O. Bighati, P.S. Singur, Dist.- Hooghly, Pin- 712124, W.B.**

1. The Secretary, WBSEB, is requested to take necessary action for the disconnection the electricity of the said units till 31<sup>st</sup> May 2007.
2. This closure order will take immediate effect and the Officer-in-Charge, Singur Police Station, under West Bengal Police, is directed to execute the Closure Order against the aforementioned units immediately and submit the compliance report to the State Board within seven days from the receipt of this Memo.
3. The concerned District Land and Land Reforms Officer, is requested not to issue the 'Consent to Operate' to the above mentioned brick-fields in question, during the period from "February to May" each year pending further instruction from this office in this regard.
4. This order has been passed as per approval of the competent authority.
