ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the Inspection Reports dated 20-03-2007 **M/S. R. I. MAX**, located at Vill. Ramdashati Main Road, P. O. – Garden Reach, P. S. – Rabindranagar, Kolkata – 700 024 is hereby closed by the Board for the reasons stated below. The power supply of **M/S. R. I. MAX** will be disconnected forthwith.

- i. That, the activity of the unit falls under “Special Red Category” as per the siting policy of the Board. No new industry under “Special Red Category” can set up their unit in the municipal corporation area of Kolkata Metropolitan Area and the unit is established violating the said siting policy of the State Pollution Control Board
- ii. That, the unit is operating without obtaining “Consent-to-Establish” and “Consent-to-Operate” from the State Pollution Control Board which is the gross violation of the environmental statute.
- iii. That, the unit is discharging its untreated effluent directly to the Kolkata Municipal Corporation drain.

The General Manager-Operations (C & M) M/S. CESC LTD. is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Rabindranagar Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Rabindranagar Police Station and the General Manager-Operations (C&M), CESC Ltd., in conformity with the order of the Hon’ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Environmental Engineer Alipore Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
