D I R E C T I O N

WHEREAS, both (1) **M/S. SHALIMAR RUBBER INDUSTRIES** and (2) **M/S. TRIVENI RUBBER WORKS** (hereinafter referred as the industries) are currently operating their rubber goods manufacturing units at B/32/H/1/1, Mahendra Roy Lane, Kolkata – 700 046

WHEREAS, inspection of both the industries was carried out by the Officials of **WEST BENGAL POLLUTION CONTROL BOARD** (hereinafter referred as the Board) on 12-03-2007. During inspection it was found that the industries in question have shifted their plants from their earlier address from 2, Mahendra Roy Lane and 1/3, Mahendra Roy Lane respectively to B/32.H/1/1, Mahendra Roy Lane, Kolkata – 700 046 without obtaining Consent-to-Establish from the Board, which was evident from the earlier inspection of the industries and the site plan submitted by the industries along with their previous and current “Consent-to-Operate” applications. During inspection it was also noted that both the industries are also operating without valid “Consent-to-Operate” from the Board. “Consent-to-Operate” for M/s. Shalimar Rubber Industries expired on March, 2001 whereas “Consent-to-Operate” of M/s. Triveni Rubber Works expired in the year 1992.

WHEREAS, a hearing was conducted in the Head Office of the Board on 12-04-2007 involving the unit .

NOW THEREFORE, in exercise of the powers conferred under Water (Prevention & Control of Pollution), Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder (1) **M/S. SHALIMAR RUBBER INDUSTRIES** and (2) **M/S. TRIVENI RUBBER WORKS** are hereby directed as under :

1. That, the industries in question will give an undertaking that they will not have any industrial activity in the vacated premises at 2, Mahendra Roy Lane and 1/3, Mahendra Roy Lane, Kolkata – 700 046 respectively.
2. That, the industries will apply immediately for “Consent-to-Establish” for the relocation of their factory premises and after obtaining “Consent-to-Establish” from the Board the “Consent-to-Operate” will be granted after submission of all due consent fees.
3. **That, the industries should individually submit the pollution cost of Rs.25,000/- (Rupees Twenty Five Thousand only) each for violating the environmental statute within ten (10) days from the date hereof by Demand Draft to be drawn**

**on Service Branch, Kolkata/Banker's Cheque in favour of WEST BENGAL
POLLUTION CONTROL BOARD.**

In case of non-compliance of the above mentioned directions by the industries, the Board may issue further regulatory order without any further reference.
