DIRECTION

WHEREAS, **M/S. HEMRAJ OILS PVT. LTD.** (hereinafter referred as the industry) operates its vegetable oil reprocessing unit at Vill. & P. O. – Chandul, G. T. Road, P. S. & Dist. – Burdwan, PIN – 713 141.

WHEREAS, an inspection of the industry carried out by the Durgapur Regional Office of the WEST BENGAL POLLUTION CONTROL BOARD (hereinafter referred as the Board) on 20-04-2007 revealed during the inspection that the industry has commissioned effluent treatment system for treatment of its liquid waste, which is inadequate and not properly maintained. There is also almost no access, to the outlet of the effluent making it difficult to collect the effluent sample. The unit operates two husk-fired boilers (12 MT/hr and 3 MT/hr.). The result of analysis submitted by the industry itself showed noncompliance of particulate emission standard in the boilers.

WHEREAS, a hearing was conducted involving the industry on 08-06-2007 in the head office of the Board.

WHEREAS, in the hearing Shri Chiranjilal Daga, General Manager, of the industry submitted that they will take effective steps for compliance of emission standards for both liquid and gaseous waste within three months time.

NOW THEREFORE, in exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder **M/S. HEMRAJ OIL PVT. LTD.** is hereby directed as follows

1. That, the industry is allowed three months time to upgrade its pollution abatement systems including effluent treatment plant for compliance of emission standard.
2. That the industry will have to submit a compliance report to the Durgapur Regional Office of the Board within this period.
3. That, the industry should submit a Bank Guarantee (proforma enclosed) for Rs.2.00 Lakhs (Rupees Two Lakhs only) valid for twelve months within fifteen (15) days from the date hereof in favour of the WEST BENGAL POLLUTION CONTROL BOARD

In case of noncompliance of the above directions within the stipulated time, the Board may initiate regulatory action against the industry without any further reference.

This has the approval of the Competent Authority.
