DIRECTION

WHEREAS, **M/S. S. G. ENTERPRISE** (hereinafter referred as the industry) is engaged in manufacturing rotter for the ceiling fans at Kalagachia Road, P. O. – Thakurpur, P. S. – Maheshtala, Kolkata – 700 063.

WHEREAS, a public complaint was lodged before the WEST BENGAL POLLUTION CONTROL BOARD (hereinafter referred as the Board) alleging smoke nuisance as well as spreading obnoxious odour. Complaint was also lodged regarding generation of noise from the engineering activity.

WHEREAS, an inspection was carried out by the Regional Office of the Board on 01-06-2007. During inspection it was noted that the industry operates a coal fired crucible furnace without any air pollution control system for controlling emission of smoke, from the furnace.

WHEREAS, a public hearing was conducted on 06-07-2007 involving the industry and the complainant at the Head Office of the Board. However, the complainant was not present during the hearing.

NOW THEREFORE, in exercise of the powers conferred under Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder **M/S. S. G. ENTERPRISE (P) LTD.**, located at Kalagachia Road, P. O. – Thakurpur, P. S. – Maheshtala, Kolkata – 700 063 is hereby directed as under :

1. The industry is allowed three (3) months for installation of adequately designed cyclone separator for controlling black smoke emission from the coal fired crucible furnace and to comply with the emission standard
2. That the industry will carry out their engineering activity responsible for generation of noise only within closed room provided with proper acoustic arrangement for minimizing emanation of noise.
3. That, the industry should submit a Bank Guarantee (proforma enclosed) for Rs.30,000/- (Rupees Thirty Thousand only) valid for twelve [12] months within fifteen [15] days from the date hereof in favour of the WEST BENGAL POLLUTION CONTROL

BOARD to ensure installation of emission control system as referred above and compliance of particulate emission standard within the stipulated time.

4. The industry will submit the compliance report after within three months to the Regional Office of the Board with a copy to the undersigned

In case of the non-compliance of the above directions by the industry within the stipulated time, the Board may have to issue necessary regulatory order without any further reference.

This has the approval of the Competent Authority.
