### **SUSPENSION OF CLOSURE ORDER WITH RESTORATION OF ELECTRICITY**

In consideration of the prayer of the industry dated 12-09-2007 and the report of the subsequent inspection by the Board Officials dated 26-09-2007, the closure order issued against **M/S. SHYAM DYEING & PROCESSING WORKS**, located at 48/1, X, Road, P. S. – Liluah, Howrah –711 108 is hereby suspended for six months from the date hereof i.e. up to 30<sup>th</sup> April, 2008 by the Board with the following conditions. The electricity connection of **M/S. SHYAM DYEING & PROCESSING WORKS** is also to be restored up to that period.

- I. That, the industry will complete commissioning of the Effluent Treatment Plant by 31-01-2008 to treat their liquid waste and comply with the liquid discharge standard.
- II. That, the industry should comply with the particulate emission standard i.e. 150 mg./Nm<sup>3</sup> for their coal/husk fired boilers by 31<sup>st</sup> January, 2008.
- III. That, the industry should submit a Bank Guarantee immediately for Rs.50,000/- (Rupees Fifty Thousand only) valid for twelve [12] months in favour of the WEST BENGAL POLLUTION CONTROL BOARD to ensure compliance of above two conditions.
- IV. That, the industry should always extend their fullest cooperation with the Officials of the Board during their inspection from time to time.

This order is issued in exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder

The Secretary, WBSEB is requested to restore the electricity connection of the industry up to 30-04-2008

In case of non-compliance of the aforementioned directions by the said unit, the State Pollution Control Board will take recourse to its earlier order without any further reference.
