SUSPENSION OF CLOSURE ORDER WITH RESTORATION OF ELECTRICITY

WHEREAS, **M/S. TEXPRO (PROPRIETOR : SOLIM MOLLA)** (hereinafter referred as the industry) operates its dyeing & bleaching unit at X-4, Akra Road, P. O. – Battala, KMC Ward No.140, Kolkata – 700 018.

WHEREAS, a closure order including disconnection of electricity was imposed upon the industry by the WEST BENGAL POLLUTION CONTROL BOARD (hereinafter referred as the Board) vide Memo No.2743-WBPCB-RO-I/HEARING & ORS./342/2007 dated 02/03-01-2008 for starting dyeing operation in their unit without obtaining “Consent-to-Establish and “Consent-to-Operate” for the same and without installing effluent treatment system for treating the liquid waste.

WHEREAS, the industry submitted a stamp paper undertaking that they will not carryout dyeing operation at the current premises till they install Effluent Treatment Plant.

NOW, THEREFORE, in consideration of the submission of the stamp paper undertaking the closure order issued against **M/S. TEXPRO [PROPRIETOR : SOLIM MOLLA]** is hereby suspended by the Board till further order with the following conditions.

1. That, the unit will only carryout detergent washing and drying of the fabrics in their premises under reference.
2. After completion of installation effluent treatment plant the industry will obtain “Consent-to-Establish” and “Consent-to-Operate” from the Camac Street Regional Office of the Board. The unit will also have to obtain “Authorization” under the Hazardous Waste (Management & Handling) Amendment Rules, 2003.
3. That, the unit will only start dyeing operation after fulfillment of condition No.2 above.

The electricity connection of **M/S. TEXPRO (PROPRIETOR : SOLIM MOLLA)** is hereby ordered to be restored immediately.

The General Manager – Operations (C&M), CESC LTD., is hereby requested to restore the electricity connection of the industry immediately.

In case of non-compliance of the aforementioned directions by the said unit, the State Pollution Control Board may take recourse to its earlier order without any further reference in the matter.

This order is issued under provisions of Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment Protection (Act), 1986 and Rules made thereunder and Hazardous Waste (Management & Handling) Amendment Rules, 2003.

This has the approval of the Competent Authority.
