DIRECTION

WHEREAS, **M/S. R. D. DYCHEM (P) LTD.**, (hereinafter referred as the industry) operates its dyeing & bleaching unit at Vill.: - Baniara, P. O. – Begri, P. S. – Domjur.

WHEREAS, the inspection of the unit on 20-11-2007 by the Officials of the **WEST BENGAL POLLUTION CONTROL BOARD** (hereinafter referred as the Board) revealed that the unit was operating its coal fired boiler emitting dense black smoke from the chimney suggesting that the emission control system (dust collector) is not adequate for controlling air pollution from the Boiler. The effluent treatment system was found not operating properly.

WHEREAS, a technical hearing of the industry was conducted on 15-01-2008 at the Head Office of the Board.

WHEREAS, the Director of the Industry appearing in the hearing submitted that modification/upgradation of emission control system is required to ensure compliance of emission level and ensuring smoke less stack and the unit appealed for allowing time up to April, 2008.

NOW THEREFORE, considering the facts and circumstances and in consideration of the submission made by the industry during hearing, **M/S. R. D. DYCHEM (P) LTD.** is hereby directed as under.

1. That, the industry is allowed time up to April 30, 2008 to complete modification/upgradation of emission control system to comply with the emission standard and ensuring smoke less stack.
2. That, the industry will upgrade its effluent treatment plant to meet liquid discharge standard within this period.
3. That, the industry should not operate its boiler without operating the pollution abatement system.
4. Discharge of untreated/partially treated liquid effluent is not permitted under any circumstances.
5. That, the industry should submit a Bank Guarantee of Rs.1.00 Lakh (Rupees One Lakh only) [proforma enclosed] valid for twelve {12} months within fifteen [15] days from the date of issuance of this order in favour of the WEST BENGAL POLLUTION CONTROL BOARD as an assurance to comply with the above directions.

In case of noncompliance of the above directions within the stipulated time as referred above, the Board will have to issue regulatory order without any further reference in the matter.

This direction is issued in exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981, Environment (Protection) Act, 1986 and Rules made thereunder.

This order has the approval of the Competent Authority.
