CLOSURE ORDER WITH DISCONNECTION OF ELECTRICITY

WHEREAS, Sri Gourango Chakraborty, Proprietor of M/s. G. Chakraborty, operates his Gate, Grill manufacturing unit at 182/1T, Bosepukur Road, KMC Ward No.91, P. O. – Bosepukur, Kolkata – 700 042.

WHEREAS, there is a public complaint alleging emanation of noise by the unit during its manufacturing activity.

WHEREAS, a public hearing was conducted at the Camac Street Regional Office of the Board on 30-01-2008 involving the unit and the complainants.

WHEREAS, during hearing the unit could not produce any statutory permission from the Board i.e. “Consent-to-Establish” and “Consent-to-Operate” excepting a Trade License for the 2006-2007 issued by the Kolkata Municipal Corporation.

WHEREAS, as per the current siting policy of the Board no Gate/Grill manufacturing unit can set up their shop within the municipal boundary of Kolkata Municipal Corporation after July, 2004 and the unit in question could not submit any documents to prove their existence before July, 2004 during the course of hearing.

WHEREAS, the unit was directed not to operate by the Board through signed Record of Proceedings issued on 22/02/2008.

WHEREAS, the Board further received a complaint that the said gate, grill manufacturing unit is continuing its operation violating the Board’s Direction.

NOW THEREFORE, in consideration of the existing siting policy of the Board and in exercise of the powers conferred and Air (Prevention & Control of Pollution) Act, 1981, Environment (Protection) Act, 1986 M/S. **G. CHAKRABORTY [Gate, Grill Manufacturing Unit] (PROP: SRI GOURANGO CHAKRABORTY)** is hereby permanently closed by the Board. The electricity connection of **M/S. G. CHAKRABORTY (Gate, Grill Manufacturing Unit) [PROP.: SRI GOURANGO CHAKRABORTY]** is also order to be disconnected forthwith.

The General Manager – Operations (C&M), CESC LTD. is requested to take action for disconnection of the electricity of the said unit immediately.

The closure order will take immediate effect and Officer-In-Charge, Kasba Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Kasba Police Station and the General Manager – Operations (C&M), CESC LTD., in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Environmental Engineer, Camac Street Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This order has the approval of the Competent Authority.
