### **DIRECTION**

**WHEREAS, M/S. TRIPTI RUBBER INDUSTRIES** (hereinafter referred as the industry) operates its rubber sheet manufacturing unit at 32, Mahendra Roy Lane, P. S. – Topsia, Kolkata – 700 046.

**WHEREAS,** the industry was called for a hearing on 19-09-2008 in the Head Office of the **WEST BENGAL POLLUTION CONTROL BOARD** (hereinafter referred as the Board) as the unit was recorded to be emitting black smoke from the stack of the boiler chimney through inspection 06-08-2008.

**WHEREAS,** on an earlier hearing the industry was instructed to make appropriate arrangement for controlling emission from their oil-fired boiler. .

**WHEREAS,** the Partner of the industry appearing in the hearing once again assured the Board that the emission of black smoke from the boiler stack will not happen in the future.

**NOW, THEREFORE,** considering the facts and circumstances stated above and submission made by the industry, **M/S. TRIPTI RUBBER INDUSTRIES** is hereby directed as follows :

1. That, the industry should maintain the boiler in proper condition to avoid black smoke emission.
2. That, the industry should always use LDO/HSD for their oil-fired boiler. The LDO/HSD to be purchased from the designated oil supplying companies and records regarding the same to be maintained properly so that the same can be produced before the Board on demand.
3. That, the industry should submit a Pollution Cost of Rs.25,000/- (Rupees Twenty-five Thousand only) by Demand Draft payable at Service Branch, Kolkata/Banker's Cheque in favour of the WEST BENGAL POLLUTION CONTROL BOARD for failing to maintain the boiler in proper condition by using recommended fuel oil, LDO/HSD and emitting black smoke emission.
4. In case of repetition of black smoke emission, the Board will issue regulatory order including closure with disconnection of electricity.

5. The Pollution Cost should be submitted within fifteen (15) days from the date of issuance of this direction. In case of non-submission of the Pollution Cost within the stipulated time the Board will have no other option other than to issue regulatory order including closure with disconnection of electricity.
