SUSPENSION OF CLOSURE ORDER WITH RESTORATION OF ELECTRICITY

In due consideration of the appeal made by the following three industries for suspension of closure order with restoration of electricity through letter dated 01-12-2008, 01-10-2008 and 24-09-2008 respectively and the inspection reports of the Board dated 08-12-2008, 16-10-2008 and 16-10-2008 respectively, the closure order issued by the Board against the industries vide Memo No.: 1375-WPBA-RED-PRL-CONT(88)03-PT-I dated 11-12-2008 is hereby withdrawn by the Board with the following conditions:

M/S. CHINKU ELECTROPLATING WORKS

1. That, the unit will operate its pollution abatement system efficiently to arrest acid fumes from its acid pickling operation and to comply with the liquid discharge standard.
2. Adequately designed on-site interim storage facility for the hazardous waste to be provided by the unit within three months from the date of issuance of this order for final disposal of the same to the common hazardous waste disposal facility at Haldia.
3. Bilingual environmental information display boards will have to be installed outside the factory main gate as per the Hazardous Waste (Management & Handling) Amendments Rules, 2003.

M/S. PIONEER TOOLS ENTERPRISE

No nickelling/electroplating activity can be started without obtaining fresh statutory permissions from the Board.

M/S. CHANDRA BRIGHT NICKEL CENTRE

1. That, the unit will operate its pollution abatement system efficiently to arrest acid fumes from its acid pickling operation and to comply with the liquid discharge standard.

2. That, the unit should become a member of the Common TSDF at Haldia for disposal of the hazardous waste generated during the process.
3. Adequately designed on-site interim storage facility for the hazardous waste to be provided by the unit within three months from the date of issuance of this order for final disposal of the same to the common hazardous waste disposal facility at Haldia.
4. Bilingual environmental information display boards will have to be installed outside the factory main gate as per the Hazardous Waste (Management & Handling) Amendments Rules, 2003.
5. That, the unit will have to obtain "Authorization" under the Hazardous Waste (Management & Handling) Amendment Rules, 2003.

The electricity connection of the above three industries is also ordered to be restored immediately.
