CLOSURE ORDER

WHEREAS, M/S. YARN PROCESSING CO. PVT. LTD., (hereinafter referred as the industry) operates its dyeing & bleaching unit at 8/J, South Sinthee Road, Kolkata – 700 050.

WHEREAS, the WEST BENGAL POLLUTION CONTROL BOARD (hereinafter referred as the Board) received a public complaint alleging water pollution by the discharge of wastewater and spreading of pungent gases by the industry.

WHEREAS, the industry was inspected by the Board Officials on 29-07-2008 and observed that the unit is operating without valid “Consent-to-Operate” since November, 2006.

WHEREAS, a public hearing was conducted at the Head Office of the Board on 03-11-2008 involving both the industry and the complainant.

WHEREAS, the representative of the industry appearing in the hearing could not explain anything for continuing operation of the unit without obtaining “Consent-to-Operate” from the Board.

NOW, THEREFORE, considering the facts and circumstances stated above, **M/S. YARN PROCESSING CO. PVT. LTD.** is hereby closed by the Board pending obtaining “Consent-to-Operate” from the Board.

This direction is issued in exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder after being approved by the Competent Authority.

The closure order will take immediate effect and Officer-In-Charge, Baranagar Police Station under West Bengal Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Baranagar Police Station in conformity with the order of the Hon’ble High Court, Calcutta dated 21-08-1998.

Environmental Engineer, Salt Lake Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order.
