### **CLOSURE ORDER**

**WHEREAS**, the **WEST BENGAL POLLUTION CONTROL BOARD** (hereinafter referred as the “State Board”) is responsible for executing different environmental laws for prevention and control of pollution within the territorial jurisdiction of West Bengal.

**AND WHEREAS**, the West Bengal Pollution Control Board received public complaint against some dyeing and bleaching units (fading of jeans and jeans apparels) situated under Maheshtala Police Station and its surroundings for causing serious environmental hazards.

**AND WHEREAS**, the State Board issued a direction on 16-10-2007 wherein 86 industrial units were directed to erect effluent treatment plant within six months for treating the obnoxious liquid waste discharged from the industrial units or install common effluent treatment plant for treating the liquid waste and also to meet the discharge norms as fixed up under Water (Prevention & Control of Pollution) Act, 1974 and Environment (Protection) Act, 1986.

**AND WHEREAS**, the State Board after the expiry of the stipulated time period monitored the pollution control system and repeated the monitoring recently whereupon it is observed that 82 numbers of units (which include some newly identified units) are still operating without installing pollution control system. The list of such industries are enclosed as Annexure-“A”

**AND WHEREAS**, the Hon’ble High Court, Calcutta, was pleased to pass an order on 13-03-2009 in connection with W. P. No.4553 (W) of 2009 wherein the State Board has been directed to issue regulatory order for control of pollution generated from the aforementioned units. Relevant portion of the order read as follows:

“It has been pointed out to us by the learned counsel for the petitioners that in spite of the order issued by the West Bengal Pollution Control Board on 16<sup>th</sup> October, 2007, the owners of the factories are continuing to operate the same without installation of the effluent treatment plant.

Mr. Basu submits that once the order has been issued by the West Bengal Pollution Control Board it has to be implemented with the aid and assistance of the municipality as well as the police authority.

We are of the considered opinion that it would be necessary to enforce the order with regard to the installation of the effluent treatment plants only if a request is made by the owners of the factories

to that effect. However, if it is found by the West Bengal Pollution Control Board that the factories are still operating without complying with the order issued by the Board, the Board shall be at liberty to take further steps in accordance with the law with regard to the closure of the units by passing necessary orders”.

**HENCE**, after due consideration of the current environmental compliance status of the 82 units as mentioned in Annexure –A and in compliance of the order of Hon’ble High Court, Klokata, the 82 Nos. of industries whose names mentioned in the Annexure “A” are now hereby directed to comply with the following directions:

**That**, all the 82 number of industries should not operate after 15-06-2009 without prior “Consent-to-Operate” of the State Board subject to compliance of the liquid discharge norms. Within such time the units are at liberty to construct their effluent treatment plant and submit their self-compliance report to the State Board.

**That**, the aforementioned 82 units are at liberty to use the premises of the units after 15-06-2009 for stitching, cutting and tailoring of cloth only. But under no circumstance dyeing, bleaching or any other related activity responsible for generation of liquid effluent will be continued. Such units who are willing to use their premises for tailoring purpose should give an undertaking to the State Board mentioning thereto that no dyeing, bleaching and related activity will continue in the area.

It is further directed that in case of any violation of the aforementioned direction, electricity connection of the 82 nos. of units (**mentioned in Annexure-“A”**) will be disconnected without any further reference and also take other regulatory action as warranted under the law.

Officer-In-Charge, Maheshtala & Rabindranagar Police Stations are directed to oversee that the aforementioned 82 units should not operate after 15-06-2009 without “Consent-to-Operate” from the Board after commissioning necessary effluent treatment plant.

This order has been issued in conformity of the direction of the Hon’ble High Court, Calcutta in exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974 and Environment (Protection) Act, 1986 after being approved by the Competent Authority.
