SUSPENSION OF CLOSURE ORDER WITH RESTORATION OF ELECTRICITY

WHEREAS M/s. SIMA PLASTIC, (hereinafter referred to as the industry) has its waste plastic grinding and washing unit at 9, Pagladanga Road, P.S. Tangra, KMC Ward 57, Kolkata-700039.

WHEREAS, the industry was directed by the **WEST BENGAL POLLUTION CONTROL BOARD** (hereinafter referred to as the Board) not to operate without prior permission of the Board vide Record of Proceedings no. 2121-2L/WPB-J(II)/2009 dt.19/05/2010.

WHEREAS, subsequently the Board directed disconnection of electricity of the industry vide memo no. 1100-2L/WPB-J(II)/2009 dt.22/06/2010.

WHEREAS, considering the prayer of the industry for restoration of electricity vide its letter dt.21/07/2010 and subsequent inspection of the industry, a hearing was conducted at the Head Office of the Board on 03-08-2010 wherein representative of the industry appeared. However, nobody appeared on behalf of the complainant.

NOW THEREFORE, in due consideration of the report of inspection, the submission of the industry and the Record of Proceedings dt.03/08/2010 issued vide memo no. 2749/2L/WPB-J(II)2009 dt.04/08/2010, the Board is hereby pleased to allow **M/s. SIMA PLASTIC** to operate for a period of **three (03) months only** from the date of issuance of this order subject to the condition that the industry will discharge effluent into the KMC drain maintaining environmental norms.

The electricity connection of the industry is ordered to be restored with immediate effect.

General Manager, Operations (C&M), CESC Ltd. is requested to take necessary steps for restoration of electricity connection of the above mentioned industry immediately.

The Environmental Engineer, Salt Lake Regional Office is requested to grant Consent to Operate to the industry for a period of **three (03) months only** from hereof. He is further requested to inspect the industry after suspension of closure order to verify the whether the industry is maintaining environmental norms and directions of the Board. If the industry is still found to operate violating the environmental norms and the directions issued by the Board, the Board will be at liberty to take further stricter regulatory action against the industry.

This direction is issued in exercise of the powers conferred under the Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder after being approved by the Competent Authority.
