SUSPENSION OF CLOSURE ORDER WITH RESTORATION OF ELECTRICITY

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in conformity with the Hon'ble Supreme Court of India – S.L.P.(C) No.4260 of 2002 (Sri Badal Chandra Mondal – VS.- The State of West Bengal & Ors.) and Hon'ble High Court, Calcutta, Civil Appeal No.2735 of 2003, W. P. No.7255(W) of 2002 the following units are hereby allowed to continue their manufacturing operations up to January, 31st 2007 with the following conditions :

CONDITIONS :

- i. That the said units is not allowed to operate between February to May each year as per the Order of the Hon'ble Supreme Court of India and Hon'ble High Court, Calcutta.
- ii. As per the Hon'ble High Court, Calcutta Order the unit will remain closed from February to May 31st every year and hence the closure order will be automatically effective on the units during that period. The police authorities are requested to implement the closure order after 31st January, 2007 and the Secretary, WBSEB is requested to disconnect the electricity of the units during that period.
- iii. That, the aforesaid units should operate maintaining the environmental norms and meeting the standards as fixed up under the aforementioned Acts and Rules made thereunder.
- iv. **That, the electricity connection of the above mentioned units should be restored for the period between 22-11-2006 to 31-01-2007**

The Secretary, WBSEB is requested to restore the electricity of the said units till 31st January, 2007

In case of non-compliance of the aforementioned direction by the said units, State Board will take recourse to earlier order without any further reference.
