ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the Inspection Report dated 26-10-2006, the following units are hereby closed by the Board for the reasons stated below. The power supply of the units will be disconnected forthwith.

- i. That, the units are operating without obtaining NOC and Consent-to-Operate from the State Pollution Control Board.
- i. That, the units are discharging untreated obnoxious liquid effluent directly to the local water bodies.
- ii. That, the units are disposing putrifiable solid waste without proper environmental management of the same.

The Secretary, WBSEB is requested to take action for disconnection of the electricity of the said units

The closure order will take immediate effect and Officer-In-Charge, Joynagar Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Joynagar Police Station and the Secretary, WBSEB, in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

The Environmental Engineer Alipore Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
