**ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY**

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the Inspection Report dated 11-12-2006 **M/S. PEERLESS CONSULTANCY INDIA PVT. LTD.**, located at,48, S. N. Roy Road, P. O. & P. S. – Behala, Kolkata – 700 038 is hereby closed by the Board for the reasons stated below. The power supply of **M/S. PEERLESS CONSULTANCE INDIA PVT. LTD.** will be disconnected forthwith.

- i. That, the unit is operating without obtaining NOC and Consent-to-Operate from the State Pollution Control Board.
- ii. That, the unit is established violating the siting policy of the State Pollution Control Board.
- iii. That, the unit is discharging untreated coloured effluent directly to the KMC drain
- iv. That, the unit has no arrangement for storing ETP sludge which is a classified hazardous waste and is disposing the same violating the Hazardous Waste (Management & Handling) Rules, 2003 and its subsequent amendments and thus attracting the order of the Hon'ble Supreme Court of India passed in W. P. (C) No.657 of 1995.

The General Manager-Operations (C&M), CESC Ltd. is requested to take action for disconnection of the electricity of the said unit.

The closure order will take immediate effect and Officer-In-Charge, Behala Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Behala Police Station and the General Manager-Operations (C&M), CESC Ltd., in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

The Environmental Engineer Alipore Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.

This has the approval of the Competent Authority.
