**SUSPENSION OF CLOSURE ORDER WITH RESTORATION OF ELECTRICITY**

In due consideration of the prayer and documents submitted by the unit vide letter dated 04/05/2015 for suspension of closure order with restoration of electricity & report of inspection conducted by the officials of the **West Bengal Pollution Control Board** (hereinafter referred to as the Board) on 08.05.2015, the Board is hereby pleased to **suspend** the order for closure along with disconnection of electricity issued vide Memo No. 885-WBPCB-RO-I/O/1117/2006 dated 04/03/2015 against **M/s. Manor Floatel Ltd.** (hereinafter referred to as the unit) located at 9/10 Calcutta Jetty, Kolkata-700001 with the following conditions:

1. **That**, the unit shall complete the modification/up-gradation & enhancement of ETP capacity within sixty days (as prayed by the unit) from hereof.
2. **That**, the unit shall operate at 50% capacity so that existing ETP can cater the effluent load and it will continue till the unit completes the modification/up-gradation & enhancement of ETP capacity.
3. **That**, the unit shall maintain a register for keeping the record of quantity of water intake/consumption.
4. **That**, the unit shall meet the environmental norms/standards of the treated effluent to be discharged to KMC sewer line.
5. **That**, the unit shall execute a Bank Guarantee (proforma enclosed) of Rs. 5,00,000/- (Rupees five lakh) only valid for twelve (12) months within fifteen [15] days from the date of issuance of this direction in favour of the **WEST BENGAL POLLUTION CONTROL BOARD** as an assurance to comply with the above mentioned directions.

**The electricity connection of the unit is ordered to be restored with immediate effect.**

**The Vice president (Distribution & Service), CESC Ltd** is requested to take necessary steps for restoration of electricity connection of the above mentioned unit immediately.

This direction is issued in exercise of the powers conferred under the provision of Section 33A of Water (Prevention & Control of Pollution) Act, 1974 and Section 31A of Air (Prevention & Control of Pollution) Act, 1981.

This order has the approval of the Competent Authority.
