DIRECTION

WHEREAS, M/s. Alom Extrusions Ltd. (hereinafter referred to as the industry) located at 184, J.N. Mukherjee Road, Bandhaghat, P.S. Malipanchghora, Howrah –711 106 is engaged in manufacturing of aluminium extruded products (sections/ profiles) - production capacity 500 MT/ month using aluminium ingot as main raw material. The industry has two (2) nos. furnace oil fired melting furnaces each of 6MT/batch capacity, one (01) no. electric heater, three (03) nos. F.O. fired aluminium billet heating furnace along with individual extrusion machine and one (01) no. ageing furnace.

AND WHEREAS, the industry was called for a hearing on 20.02.2015 by the **West Bengal Pollution Control Board** (hereinafter referred to as the Board) on receiving a mass public complaint against the industry alleging severe air pollution. During the said hearing, the MD of the industry submitted that they had decided to relocate the activity from present location (184 J.N. Mukherjee Road, Howrah) to their other plot at Banganagar, Falta, D.H. Road, Dist 24 Pgs. (South).

AND WHEREAS, a shifting order was issued to the industry by the Board vide Memo No. 897-PCB/How/82-97 dated 18.03.2015 directing the industry to shift the plant from the present location.

AND WHEREAS, an inspection of the industry was conducted by the Board official on 21.02.2017 and the industry was found operating at the existing premises.

AND WHEREAS, the 'Consent to Operate' of the industry was valid upto 31.01.2015 (fees cleared upto 31.012018).

AND WHEREAS, the industry was called for a hearing on 18.04.2017 for the above mentioned violation of Board's direction.

AND WHEREAS, the representatives of the industry appeared in the hearing and submitted that they have obtained Consent to Establish for the new location at Banganagar, Falta, D.H. Road, Dist 24 Pgs (S). He also stated that shifting of machineries to the new location is in progress and it will be completed within June 2017.

NOW THEREFORE, considering the above, **M/s. Alom Extrusions Ltd.** located at 184, J.N. Mukherjee Road, Bandhaghat, P.S. Malipanchghora, Howrah –711 106 is hereby directed not to undertake any production activity at the existing premises and shifting of machineries from the present location to the plot at Banganagar, Falta, D.H. Road, Dist. 24 Parganas(South) shall be completed within 30th June, 2017 positively. The industry shall submit a compliance report in this regard to the Board.

The Environmental Engineer, In-charge, Howrah Regional Office of the Board is requested to conduct an inspection of the industry after June, 2017 to verify the status of compliance of the Board's direction. In case of any violation of the Board's direction, the Board will issue regulatory action including closure with disconnection of electricity without any further reference.

This direction is issued in exercise of the powers conferred under the Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and the Environment (Protection) Act, 1986 and Rules made thereunder, after being approved by the competent authority.
