DIRECTION

WHEREAS, M/s. Srijan Realty Pvt. Ltd. (previously Srijan Projects Pvt. Ltd.) [hereinafter referred to as the unit] located at **Mouza: Santa, Chitra More, P.O. & P.S.- Hirapur, Asansol, Dist.- Burdwan, Pin – 713 325** is a shopping mall including shops, showrooms, restaurants etc. (total built up area-16,426.55 sq.m).

AND WHEREAS, as per order of Hon'ble National Green Tribunal, Eastern Zone Bench, Kolkata, the unit was inspected by the official of **West Bengal Pollution Control Board** (hereinafter referred to as the Board) on 31/12/2015. Total water consumption is 104 KLD and total water is supplied by Asansol Municipal Corporation. The unit has not installed any sewerage treatment plant (STP) and waste water is finally discharged to Asansol Municipal Corporation drain without any treatment. No green belt was noticed during inspection.

AND WHEREAS, the unit was again inspected on 27/01/2016 and during inspection effluent samples were collected from two outlets of the unit. Analysis report of the effluent samples shows gross failure in complying with the standards.

AND WHEREAS, the unit obtained Consent to Establish from the Board on 26/09/2006. The Consent to Operate of the unit is valid upto 30/09/2018.

AND WHEREAS, a hearing was conducted at the Head Office of the Board on 03/02/2016 for the non-compliance of environmental norms as recorded above.

AND WHEREAS, the representatives of the unit appearing in the hearing submitted that they would submit a time bound action plan regarding installation of STP and take necessary steps for tree plantation.

NOW THEREFORE, considering the above, **M/s. Srijan Realty Pvt. Ltd. (previously Srijan Projects Pvt. Ltd.)** located at Mouza: Santa, Chitra More, P.O. & P.S.- Hirapur, Asansol, Dist.- Burdwan, Pin – 713 325 is hereby directed to submit a time bound action plan to the Board within 29th February, 2016 regarding installation of STP alongwith its details. The unit is further directed to take necessary steps for green belt development in and around the unit.

The Environmental Engineer, Asansol Regional Office of the Board is requested to follow up the matter regarding installation of the STP after submitting the time bound action plan by the unit.

This direction is issued in exercise of the powers conferred under the provision of Section 33A of Water (Prevention & Control of Pollution) Act, 1974, the Environment (Protection) Act, 1986 and Rules made thereunder after being approved by the Competent Authority.
