### ORDER FOR CLOSURE

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981, Environment (Protection) Act, 1986 and Rules made thereunder and Hazardous Waste (Management & Handling) Rules, 2003 and its subsequent amendments and in consideration of the Report of Inspection dated 05-01-2007, carried out in reference to a public complaint, **M/S. SENIOR FOOTWEAR PRODUCTS PVT. LTD., UNIT-I & UNIT – II** located at 61/1Z/32, Topsia Road, Kolkata – 700 039 are hereby closed by the Board for the reasons stated below.

- I. That, the units is operating without obtaining the Hazardous Waste Authorisation for handling the E.T.P. sludge from dyeing & bleaching operations, .violating the Hazardous Waste (Management & Handling) Rules, 2003 and its subsequent amendments thus attracting the provisions of the Hon'ble Supreme Court Order passed in W. P. (C) No.657 of 1995
- II. That the units are creating obnoxious pungent odour arising out of vulcanizing, calendering, rolling & mixer kneading machines.
- III. That, that units are not taking proper care in handling of china clay bags while loading and unloading activity in their godown to reduce the emission of fugitive dust .
- IV. That, the units are creating noise pollution due to operation of their heavy machineries.
- V. That, the units are operating without fire license inspite of using flammable items for their process operations.
- VI. That the units failed to submit the fire license till date inspite of given opportunity to do so in the hearing held on 02-02-2007

The closure order will take immediate effect and Officer-In-Charge, Tiljala Police Station under W.B. Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Tiljala Police Station, in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

The Environmental Engineer Camac Street Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the units involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order.

This has the approval of the Competent Authority.
