SUSPENSION OF CLOSURE ORDER WITH RESTORATION OF ELECTRICITY

In exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder and in consideration of the appeal of the industry dated 28th May, 2007, **M/S. MILLENIUM FORGE & ENGINEERS PRIVATE LIMITED**, located at 20, Belur Road, Liluah, P. S. – Bally, Dist. – Howrah, PIN – 711 204 is hereby allowed to operate till 30th November, 2007.

- I. That the unit should upgrade its Air Pollution Control System for the coal fired boiler within 30^{the} November, 2007 to ensure compliance of particulate emission standard as also smokeless stack.
- II. That the unit should not operate its boiler without operating the pollution control system attached to it.
- III. That the unit should submit a compliance report to the Howrah Regional Office of the Board with a copy to the undersigned.
- IV. That, the unit should submit a Bank Guarantee (proforma enclosed) of Rs.1.00 Lakh (Rupees One Lakh only) [valid for twelve months] in favour of WEST BENGAL POLLUTION CONTROL BOARD within seven (7) days from the date hereof to ensure compliance of the environmental norms as per assurance given by the unit in their appeal dated 28th May, 2007
- V. That the said industry should submit Pollution Cost of Rs.50,000/- (Rupees Fifty Thousand) only, within seven (7) days from the date hereof by Demand Draft to be drawn on Service Branch, Kolkata/Banker's Cheque in favour of West Bengal Pollution Control Board for operating the coal fired boiler without operating the pollution control system attached to the boiler as was revealed from the inspection and monitoring of the Board dated 21-02-2007.

The Secretary, WBSEB is requested to restore the electricity connection of the industry in question up to 30th November, 2007.

In case of non-compliance of the aforementioned directions by the said unit, the State Pollution Control Board will take recourse to its earlier order without any further reference.

This order has the approval of the Competent Authority.
