## SUSPENSION OF CLOSURE ORDER INCLUDING RESTORATION OF ELECTRICITY

In due consideration of the fact that the industry has submitted application for "

"Consent-to-Establish" for the husk-fired boiler and also submission by the industry that they will complete the installation of emission control system by 30<sup>th</sup> November, 2008 the closure orders issued by the Board vide Memo No.:973-347/WPB(HRO)K/01 dated 02-07-2008 against **M/S. KANAK SOLVO PVT. LTD.**, located at P. O. – Medinipur, P. S. – Kotwali, Dist. – Paschim Medinipur is hereby suspended with the following conditions:

- 1. The closure will remain suspended till 30th November, 2008.
- 2. That, the unit will have to complete commissioning emission control system (preferably Bag filter) for the husk-fired boiler within this period to comply with the particulate emission standard
- 3. That, the unit will have to upgrade/modify the Effluent Treatment Plant to comply with the liquid discharge standard.
- 4. That, the unit will have to obtain renewal of "Consent-to-Operate" from the Haldia Regional Office of the Board immediately.
- 5. That, the unit will have to submit a Bank Guarantee of Rs.1.00 Lakh (Rupees One Lakh) [proforma enclosed] valid for twelve [12] months within fifteen (15) days from the date of issuance of the direction in favour of the **WEST BENGAL POLLUTION CONTROL BOARD** as an assurance to comply with the above directions within the stipulated time.

## That, the electricity connection of the industry is also ordered to be restored.

The Secretary, WBSEB is requested to take action to restore the electricity connection of the industry up to 30-11-2008.

This direction has been issued in exercise of the powers conferred under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and Rules made thereunder after being approved by the Competent Authority.
