ORDER FOR CLOSURE WITH DISCONNECTION OF ELECTRICITY

WHEREAS, **M/S. SATAR DYER** (hereinafter referred as the unit) operates its dyeing unit at 85, Park Street, Nawab Manasion, Kolkata – 700 016.

WHEREAS, a public complaint was lodged before the WEST BENGAL POLLUTION CONTROL BOARD (hereinafter referred as the Board) alleging discharge of untreated liquid effluent and damage of the building from the activities of the unit.

WHEREAS, the report of inspection carried out by the Board Officials on 23-10-2008 revealed the following:

- 1. The unit is situated on the roof top of the Nawab Mansion.
- 2. The Nawab Mansion is an old two storied building.
- 3. The unit operates four nos. of coal-fired chullahs without any air pollution control system.
- 4. The unit has no arrangement for treating its liquid waste and the wastewater is being discharged directly to the KMC sewer line.
- 5. The unit is operating without obtaining "Consent-to-Establish" and "Consent-to-Operate", which is gross violation of the environmental statute.

WHEREAS, a public hearing was conducted at the Head Office of the Board involving both the complainant and the unit on 12-12-2008. Neither any representative from the industry nor the complainant appeared for the hearing.

NOW, THEREFORE, considering the facts and circumstances as stated above and the recalcitrant attitude on part of the unit towards statutory body **M/S. SATAR DYER** is hereby closed by the Board. The electricity connection of the unit is also directed to be disconnected immediately.

M/S. **SATAR DYER** is also hereby directed to shift their unit to a suitable location where the unit can operate maintaining all environmental norms.

The General Manager – Operations (C&M) is requested to take necessary arrangement to disconnect the electricity connection of the industry immediately.

This order is issued in exercise of the powers conferred under Water (Prevention & Control of Pollution), 1974 Air (Prevention & Control of Pollution) Act, 1981, and Environment (Protection) Act, 1986 and Rules made thereunder after being approved by the Competent Authority.

The closure order will take immediate effect and Officer-In-Charge, Park Street Police Station under West Bengal Police, is directed to execute the Closure Order against the aforementioned unit and submit the compliance report to the State Board within seven days from the receipt of this Memo.

This direction has been issued to the Officer-In-Charge, Park Street Police Station and the General Manager – Operations(C&M), M/S. CESC LTD., in conformity with the order of the Hon'ble High Court, Calcutta dated 21-08-1998 and 28-04-1999 respectively.

Environmental Engineer, Camac Street Regional Office of the State Board is requested to take necessary steps for proper execution of the closure order and also visit the unit involving the local police station and Nodal Police Officer of the concerned district to oversee the proper execution of the closure order and also ensure the disconnection of electricity of the unit.
