DIRECTION

WHEREAS, the West Bengal Pollution Control Board (hereinafter will be referred to as the 'State Board') is entrusted with the enforcement of the provisions of the Air (Prevention and Control of Pollution) Act, 1981 and the Environment (Protection) Act, 1986 and Rules made thereunder for the purpose of protection of environment and for the prevention and control of pollution in the State of West Bengal;

AND WHEREAS, it is observed from the records kept and maintained by the State Board that 100 (One Hundred) numbers of Barowaries / Puja Committees were identified to have violated the provisions under the Noise Pollution (Regulation & Control) Rules 2000, and its subsequent amendment issued under Environment (Protection) Act, 1986 as well as orders of the Hon'ble High Court, Calcutta during the Puja Festive Season 2006;

AND WHEREAS, it is also observed from the records kept and maintained by the State Board that the State Board issued an order directing 100 (One Hundred) numbers of Barowaries / Puja Committees, vide Memo No. 79 (1-143)-76L/WPB/2005-Part-I, dated 27-04-2007, to submit undertaking within 15 days to the effect that, they would abide by the provisions under the Noise Pollution (Regulation & Control) Rules 2000, and its subsequent amendment issued under Environment (Protection) Act, 1986 as well as orders of the Hon'ble High Court, Calcutta;

AND WHEREAS, the said Barowaries / Puja Committees in the said order were also to submit pollution cost to the tune of Rs. 2,000/-(Rupees Two thousand) only each to be donated to any Voluntary Organization within 15 days from the date of receipt of the order and also to submit compliance report along with the copy of receipt to the State Board and also to the Officer-in-Charge of the local Police Station;

AND WHEREAS, it is observed that out of 100 (One Hundred) numbers of such violators, only 14 (Fourteen) nos. of Barowaries / Puja Committees have complied with the order issued by the State Board;

NOW THEREFORE, in exercise of the powers conferred under the Environment (Protection) Act, 1986 read with the Noise Pollution (Regulation & Control) Rules 2000, and the Air (Prevention & Control of Pollution) Act, 1981, as amended time to time, and also in view the orders passed by the Hon'ble High Court, Calcutta, all the Officer-in-Charge of concerned Police Stations under West Bengal Police & Kolkata Police, are hereby directed that, not to issue permissions, to the 86(Eighty-six) nos. of Puja Committees under their respective jurisdictions, to Organize Barowari Puja, unless they submit undertaking, compliance report and copy of receipt of submission of Pollution Cost to the Local Police Station concerned as well as the State Board, as directed vide order dated 27-04-2007, issued by the State Board.

2. The Officer-in-Charge of the concerned Police Station should also submit a report to the State Board indicating the compliance of the said order by the Barowaries / Puja Committees under their respective jurisdictions.
